**Rules and Regulations (Applicants must check each box acknowledging you have read and understand the following.)**

- DOT or SNELL approved helmets must be properly worn at all times when the machine is in motion.
- Photo identification must be carried by all operators.
- Proof of valid state registration and insurance must be carried when operating an ATV/UTV.
- ATV operators ages 8-15 must be in possession of a training certificate. No one under 8 years of age may operate an ATV or OHM.
- Use of any alcohol or other controlled substances is strictly prohibited when operating any off road vehicle.
- Ride ONLY on designated trails and obey all traffic control devices.
- Operators under the age of 10 are restricted to an ATV/OHM with an engine size of 70cc or less.
- The speed limit on all off-road vehicle trails is 25 miles per hour.
- Penoke, Rocky Gap, and Willow Creek trails have a maximum allowed width of **50 inches** including all equipment on the machine.
- Timberline and Marienville trails have a maximum allowed width of **64 inches** including all equipment on the machine.
- Passengers under 8 years of age can only ride in a "Side by Side ATV" with an approved child safety seat. Any passengers less than 4 years of age, or weighing less than 40lbs., or under the height of 4'9" must use a child restraint device. Any passenger between ages 4 and 7 and weighing less than 80 lbs. and/or any passenger under the height of 4'9" must be fastened in a factory-installed ATV seat belt system with the use of an approved booster seat.

I certify that all information given above is true and accurate. I also understand that providing false information on this form is a violation of Title 36 of the Code of Federal Regulations, Section 261.3(b) and is punishable by a fine of up to \$5,000 and/or six months imprisonment. I understand that operating or using off-road vehicles involves risks, dangers, and hazards that may cause serious personal injury or death. Risks include, but are not limited to, changes in terrain, weather, rocks, trees, signs, buildings, roads, and other terrain features. Other hazards may exist that are not marked. I acknowledge that the risks of operating off-road vehicles can be greatly reduced by receiving training, abiding by all laws, and using common sense. As a permit holder, I will abide by all laws. I also acknowledge that this permit can be revoked by any law enforcement officer or Forest Service official for failing to adhere to all state, federal, and/or local laws and regulations.

## Instructions

**Personal Information:** Fill in your name, complete mailing address, phone number, and date of birth. If using the digital form, you may use the drop down calendar to select your date of birth.

**Vehicle Information:** Fill in all fields. For Type, only fill in ATV, UTV, or OHM. The digital form uses a drop down to select the appropriate type.

**ATV/UTV Required Documentation:** If you are applying for an OHM permit, you do not need to fill this section in. For ATV/UTV permits, all fields MUST be filled in. Registration State must be Pennsylvania (PA) or a reciprocal state. When using the digital form, if your state is not in the drop down, you MUST ensure your state has reciprocity with Pennsylvania. You may use the drop down calendar on the digital form for all expiration dates.

**Copies of your registration and insurance must be provided with your application.** These are not retained. If applying in person, your documents will be returned to you. Photocopies must be sent with a mailed-in application. Scanned or photographed documents must accompany an application by e-mail.

**Type of Permit Requested:** Mark whether the application is for a ATV/UTV or OHM and either Annual or Daily permit. If applying for a Daily permit, you MUST include the date you want the permit for. If you are mailing in your application, the date must be at least 2 weeks from the date of mailing to ensure timely receipt of the pass.

**Method of Payment:** Select one of Cash, Check/Money Order, or Credit/Debit.

Cash payments may only be made in-person at headquarters or a ranger station. Never send cash in the mail.

Check or money order made out to USDA Forest Service may be sent by mail with the application or paid in person at headquarters or a ranger station.

Credit or debit card payment may be made in-person or over the phone. For payment by phone, ensure the phone number included on the application is one at which you are available Monday through Friday 8:00am—4:00pm. One of our support services staff will call you to take your payment by phone. This is the only accepted method of payment when applying by e-mail. DO NOT include credit card information with an application sent by mail or e-mail.

**Rules and Regulations:** Read and mark each rule and regulations, indicating that you have read the rule. Read the paragraph at the end of the page. If you agree to everything in the statement, sign and date the document. If you are using the digital form, a digital signature with the date and time is acceptable.
